Participants' preparation exercises

These questions form a “preparation exercise” for persons about to participate in an ISAF IJ Seminar. An IJ seminar is not a “rules seminar” so RRS Parts 2 and 3 do not form part of the seminar. Participants are expected to have a good knowledge of these rules before attending a seminar and this knowledge will be tested as part of the written judges' test. These exercises allow you to test your present knowledge of the racing rules and they may improve your rules knowledge at the same time.

Some of the questions will require you to search your RRS to identify the actual rule or rules which indicate the answer. As you proceed you may find you will be moving more quickly because the applicable rules become easier to identify and you become more familiar with the location of the rules within the book. Being able to locate a rule quickly will be of help during the written test.

NOTES ON COMPLETING THE QUESTIONS

Do not assume any special circumstances not stated in the question (for example, do not assume that any special starting rule is being used).

Do not overlook the definitions, which are also important rules.

As it is an obligation of all boats to avoid contact if reasonably possible (rule 14) it is not necessary to record this in each answer. Also, because rule 16.1 always applies, it is not necessary to record in each answer that the right of way boat has an obligation to give room if she changes course.

Question 3 has already been completed so as to give an example of the way the questions should be answered.
